Title of the training

Focus IP Patents

Public

This training cycle is exclusively organized online in English language. It is intended for patent attorneys, attorneys, company lawyers, judges, paralegals and for anyone dealing with patent law in her or his daily professional practice, as well as for IP students.

Prerequisites/Entrance requirements

Participation in this non-degree training does not require any specific prerequisites.

Objectives

CEIPI is organizing, as from February 2025, a new annual continuous training cycle dedicated to patent law. It is intended for patent attorneys, attorneys, company lawyers, paralegals and for anyone dealing with patent law in her or his daily professional practice.

The modules will take place as monthly two-hour webinars, usually every first Friday of the month. They give the opportunity to patent practitioners to keep up to date on topics related to their professional experience. The webinars are presented by recognized international experts. Each webinar deals with a specific topic of patent law.

Program (subject to later changes)

- 1. Comparison of law and practice concerning patentability and added subject-matter in different European jurisdictions, and in the framework of the EPC and the UPC (7 February 2025)
- 2. Law and practice of employees inventions in different countries (7 March 2025)
- 3. Computer implemented inventions and AI in the patent system (4 April 2025)
- 4. Supplementary protection certificates (SPC) for pharmaceutical and plant protection products: case law of the CJEU and in different European jurisdictions (9 May 2025)
- 5. Plausibility and inventive step following G 2/21 (6 June 2025)
- 6. Patent infringement seizure (order to preserve evidence): a comparison between France and UPC (4 July 2025)
- 7. The Dual German Patent System: Two separate proceedings for validity and infringement (5 September 2025)
- 8. Standard Essential Patents: Law and practice in different countries and according to the UPC (3 October 2025)
- 9. Claim construction following the referral in G 1/24 / State of the art following the referral in G 1/23 (7 November 2025)
- 10. Tips & tricks in US patent prosecution (5 December 2025)

Duration and time frame

The training cycle comprises 10 two-hour webinars usually held every first Friday of the month, from 12:30 to 14:30 CET (for some exceptions to this schedule refer to the detailed programme). It is possible to either attend some of the webinars only, or to enrol for the whole cycle of 10 sessions.
