

<p><b>Title of the training</b></p> <p>Introductory methodology courses for papers A, B, C and/or D of the European qualifying examination (EQE) 2025</p>
<p><b>Public</b></p> <p>The training is intended for people taking Papers A, B, C and / or D of the EQE. To register for this paper with the EPO, candidates must meet the EPO's requirements (see the new EEQ regulations, OJ EPO 2024, A4).</p>
<p><b>Prerequisites</b></p> <p>Participation in this non-degree training course does not require any specific prerequisites with regard to the target audience.</p>
<p><b>Entrance requirements</b></p> <p>This is a non-degree training course. Admission upon validation of the application file.</p>
<p><b>Objectives</b></p> <p>Help candidates prepare as early as possible for the EQE and bring them to the required level for the CEIPI preparatory seminars for papers A, B, C and D of the EQE.</p>
<p><b>Program and schedule (for information purposes)</b></p> <p><b>Content :</b></p> <ul style="list-style-type: none"> <li>- Introduction to methodologies for solving papers A, B, C and/or D of the EQE</li> <li>- Identification of the competences which candidates must develop in order to pass the examination papers</li> <li>- Explanation of examination requirements and review of important topics for each paper</li> </ul> <p><b>Duration :</b> 0.5 day (4h) for A, 0.5 day (4h) for B, 1 day (6h50) for C, 1.5 day (10h05) for D.</p> <p><b>Dates :</b> A and B: 13/09/2024, C: 14/09/2024, D: 11(afternoon) - 12/09/2024</p> <p><b>Provisional schedule :</b></p> <p>9 a.m. - 1 p.m. for A, 1 p.m. - 6 p.m. for B; 9 a.m. - 6 p.m. for C; 2 p.m. - 6 p.m. and 8.30 a.m. - 5 p.m. for D</p> <p><b>Tutors :</b></p> <p>The tutors for these courses are either professional representatives (from private practice and industry) or staff of the departments of first instance of the EPO and of the Boards of Appeal. All have extensive knowledge and practical experience in the procedures before the EPO, be it in examination and opposition, or in appeal before the Boards of Appeal. A detailed list of course tutors and their references will be made available to participants before the start of the course.</p>
<p><b>Teaching methods</b></p> <ul style="list-style-type: none"> <li>- Presentations and discussions, Q&amp;A sessions</li> <li>- Practical exercises and discussion of solutions with tutors</li> <li>- Work sessions in small groups in order to ensure proper dialogue between tutor and participants</li> </ul> <p>The courses are proposed in the three EPO official languages (English, German, French).</p>
<p><b>Training material</b></p> <ul style="list-style-type: none"> <li>- Course material and handouts in paper or electronic form</li> <li>- A- B and C-book</li> </ul>
<p><b>Validation</b></p> <ul style="list-style-type: none"> <li>- The training aims at the adaptation and development of skills. Participants will receive an attendance certificate.</li> </ul> <p>An evaluation questionnaire will be distributed at the end of the course in order to measure client satisfaction.</p>
